STUDENT INFORMATION

GENERAL INFORMATION

- You may receive credit for the .5 Sports for Physical Education Credit (250 G) **one time only**.
- 9th Grade CORE Physical Education credit cannot be substituted with course 250 G.
- "Activities/Athletics" are defined as a WIAA-approved junior varsity and/or varsity level team sport, cheerleading and/or drill team. Water Polo and Lacrosse are **not** eligible.

PROCEDURES

- Forms to request this credit are available in the Counseling Center and the Athletic packet of materials received from your coach.
- The form must be completed and turned in to the advisor/coach by the **end of the second week of the season**.
- The forms will be kept by the advisor, coach and/or Athletic Director until the end of the season.
- Upon **successful** completion of the activity/sports season, the student, advisor/coach and the Assistant Principal or Athletic Director must complete Part B.
- The signed, completed form must be turned into the Counseling Center, by the advisor/coach or Athletic Director, within **two weeks of the end of the season**.

REQUIREMENTS TO RECEIVE CREDIT:

- Time spent in the activity/sport must meet or exceed 75 hours of practice/game time.
- You must attend 90% of all practices and games.
- You must complete and submit the required paperwork within the stated timelines.

NO CREDIT WILL BE GIVEN IF:

- Paperwork is not completed in the required timelines.
- You drop out or are dismissed from the activity/sport.
- You do not attend 90% of all practices and games.
